## **EXPRESS BUS STOP SURVIVES, CROSSTOWN SERVICE CUT**

Since writing this article, city agencies have agreed to keep the express bus stop between 49th and 50th Streets on First and Second Avenues. Cross-town service on 50th and 49th Streets has been eliminated or curtailed, as detailed below.

In April 2010, the MTA confirmed that it would implement drastic cutbacks to the cross-town buses serving Turtle Bay. Proposed changes included:

- Eliminating the M104 making round trips between 129th Street and Broadway and 42nd Street and First Avenue.
- Eliminating the M27 running from First Avenue to the Port Authority Bus Terminal and back via 49th and 50th Streets.
- Eliminating the M50, which runs along 49th and 50th Streets from First Avenue

to the Hudson River, on weekends and late night on weekdays.

Completing the isolation of Turtle Bay, the MTA and NYCDOT decided to drop their original plan for express bus stops between

49th and 50th Streets along the new Select Bus Service (SBS) route running north and south on First and Second Avenues between Houston and 125th Street. That left a yawning 15-block gap between the nearest express stops on 42nd and 57th Streets.

Upon hearing the announcement, the Turtle Bay Association acted immediately. Together with Community Board 6 (CB6) we arranged a meeting with MTA and NYCDOT officials, attended by our elected representatives. We detailed our concerns, adding that a "perfect storm" of service cuts and omissions had left our community bereft of adequate bus service connecting us to the rest of the East Side as well as Midtown, Lincoln Center and the Theater District. The agencies promised to review

the situation; however, their commitment to report back by May 12 was delayed. During the following days we circulated petitions, flyers and e-mails notifying our membership and the community of the impending bus cutbacks.

The CB6 Transportation Committee prepared a resolution conditioning approval of the SBS system on the reinstatement of both the 49th-50th Street express stops and all of the crosstown routes. The TBA pushed for combining the two issues, believing that an omnibus resolution would carry more force. Nevertheless, on May 23, CB6 overwhelmingly approved two separate resolutions: the first tied approval of the SBS system to the reinstatement of the 49th-50th Street express stops. The second was an independent demand to maintain existing cross-town bus service.

Enter our U.S. congressional representative Carolyn Maloney, who took up the cudgel on our community's behalf. On June 4, she announced her success in persuading the MTA and NYCDOT to reinstate the 49th50th Street express stops, since confirmed by the DOT. Maloney also promised to continue fighting against the cutbacks to our cross-town service.

Between now and October, the MTA and NYCDOT will be readying First and Second Avenues for the SBS system: repaving and adding painted lines and surfaces to mark bus and protected bicycle lanes. There will be no parking weekdays, 7 am to 10 am and 2 pm to 7 pm. Truck deliveries will be permitted only between 10 am and 2 pm, and general metered parking between 7 pm and 7 am.

Within Turtle Bay there will be a single bus lane along the right-hand curb. It remains to be seen whether this can deliver true express service, since both express and local buses will occupy the one lane, lagging behind each other unless traffic permits them to swing out into the adjacent lane to pass.

Despite attempts to preserve cross-town service, the M27 and M104, and M50 late night and weekend service were eliminated as of 12:01 am, June 27, 2010.

## Vanderbilt YMCA to Host U.S. Diabetes Prevention Program

Beginning at the end of July, the Vanderbilt YMCA will offer a free Diabetes Prevention Program aimed at helping those at risk fight the development of type 2 diabetes. The program is part of a U.S. government initiative and has been proven to cut participants' chances of developing the disease by more than half.

The program is conducted in a group setting. The goals are to help pre-diabetics achieve and maintain weight loss of at least seven percent via healthy eating and physical activity of at least 150 minutes a week. A trained lifestyle coach will work with participants for 16 core sessions to help them change their lifestyles. After the sessions, participants will continue to meet monthly for up to a year for added support

in maintaining their progress.

The program is scheduled to begin the last week of July. To enroll, participants must be diagnosed as pre-diabetic and must present a signed referral form from their primary care physician. #### The Turtles of New York

Is Turtle Bay named for the turtles that lived here in earlier days? Though no one is sure, we do know that many different turtle species inhabited the neighborhood long before we arrived.

Meet the Green Sea Turtle, aka Chelonia mydas. This turtle is actually olive-brown to black above and yellowishwhite below. Its nesting cycle may be two to five years apart, often requiring long-distance migration between foraging and nesting grounds. Several clutches of eggs hatch after 48-70 days, and send the hatchlings racing towards the ocean. They are thought to live for 20+ years.

Once abundant in the oceans and along the eastern and southern U.S. coasts, green sea turtles have drastically declined due to commerce, pollution, sand mining, degradation of nesting and feeding areas, and trawl net fishing. ## **Elected Officials at Work**

#### Garodnick Co-Hosts Meeting on Future of East Side Waterfront

Along with Senator Liz Krueger and Assemblyman Brian Kavanagh, Council Member Garodnick hosted a town hall forum on June 6 to discuss the future of the East Side waterfront and parks. The Parks Department and the Economic Development Corporation introduced a proposal to develop a tower for the UN on a portion of Robert Moses Playground, and to use funds from the development to construct new open space along the waterfront. Garodnick noted that Community Board 6 has the least open space in the city and kept the way open to additional community discussion.

# **Garodnick Confronts Google on Data Privacy**

In a letter to Eric Schmidt, Chairman and CEO of Google, Council Member Dan Garodnick asked for an explanation of Google's collection of personal information from Wi-Fi servers over the past three years. Google has acknowledged that its "Street View Van," which captures images for its Googlemaps "Street View" feature, was collecting personal information from unsecured Wi-Fi connections around the world, including e-mails, instant messages, and what websites a person had visited. Garodnick is Chair of the City Council's Committee on Technology.

#### **Lappin Appointed to Two Posts**

Council Member Jessica Lappin has been named Chair of the Women's Caucus in the City Council. She will work with Co-Chair, District 2 Council Member Rosie Mendez to tackle the wide array of issues important to women in the city.

Lappin has also been appointed to sit on the City Council's Budget Negotiating Team.

# Lappin Introduces Legislation to Expand Recycling in New York

New legislation introduced by Jessica Lappin will double the number of recycling bins available to the public over the next three years and more than triple the number over the next 10 years. The legislation will also create New York's first-ever program for recycling textiles, such as clothes and towels, which can be resold, producing revenue for the city.

# Krueger Supports State's Chances for Federal Education Funds

On May 28, Senator Liz Krueger voted for a package of legislation that she believes will improve New York State's public education. This includes student improvement in teacher evaluation; increasing our chances of receiving Federal "Race to the Top" education funds; and raising the cap on the number of Charter Schools while increasing their accountability.

# Krueger Backs Sale of Wine in Groceries

Senator Liz Krueger is sponsoring legislation to allow wine sales in grocery stores as a way to rein in service cuts and raise revenues without raising taxes. Krueger estimates the state would gain \$300 million in new franchise fees, and has cited a Cornell study estimating that yearly sales of wine would increase by \$22 million.

# Bing Bills Passed that Expand Housing for Disabled

The Assembly recently passed Bing's legislation to give state agencies enforcement capability over the Federal Rehabilitation Act. The law requires that housing developments financed with federal money provide accommodations for individuals with disabilities, and make efforts to advertise available disability housing to relevant groups. In many cases, even those developers who have accepted federal funds and are in architectural compliance have not marketed these accessible units to eligible individuals with disabilities.

The Assembly also passed Bing's legislation to prohibit discrimination by landlords on the basis of a tenant's source of income. Currently, landlords may reject tenants with rental subsidies, such as Section 8 vouchers, merely because tenants intend to use them for payment of rent. Many people with disabilities rely on those subsidies and other assistance programs to live independently in the community.

Ground broken for PS 59 and School of Art and Design. After months of delays, ground has officially been broken for the new state-of-the-art school facility at Second Avenue and 57th Street, adding desperately needed school seats to the East Side. The school is expected to open in the fall of 2012. The project is being built and paid for by a private developer

Marine Transfer Station Project Delayed. The Department of Sanitation has delayed its proposed Marine Transfer Station at East 91st Street, and now plans to bring it on-line sometime in or after 2014. Jessica Lappin views it as a good thing given the city's budget woes.
